**Scott Green
Central Bucks -- 1969**

Scott was a Varsity player on the Football and Track teams but as he wrote in a 7th grade paper, "Football will be a big part of my life."

Football

At Central Bucks, Scott was a three-year starter at Linebacker, Placekicker and Fullback. In his Senior year he was elected Co-Captain.

- On the field for all kick-offs.
- Kicked 52 extra points and a 36 yard field goal.
- Played on the 1967 undefeated Bux-Mont Championship team that included Central Bucks HOF inductees Eric Bass and Andy Syme.
- All Bux-Mont and All Intelligencer Linebacker in his Junior and Senior years.
- Honorable Mention Big 33 in his Senior

Track

As a way of staying in shape for Football, Scott joined the Track Team. He competed in the Javelin and in his Senior year broke a nine year school record throwing it at 176'4".

After high school he attended the University of Delaware where he played Football for three years. In his Junior year at Delaware the team won the Small College National Championship. Although a knee injury ended his football career, Scott wanted somehow, to remain in the sport. He graduated from the University of Delaware in 1973 with a B.S. in Criminal Justice.

After graduation he sat down with Walt Smerconish (HOF Coach Inductee, 2010) whose profession as a football referee is well known to Bucks County sports fans. Scott wrote in his email to the Hall of Fame that the "conversation and suggestions" with Walt led him to begin a new career as a referee. In 1991 he was selected to be one of the 120 referees in the National Football League. During his 23 years he officiated in over 350 regular season and post season games, culminating with his selection to Super Bowls XXXVI, XXXVIII and XLIV, first as a Back Judge and later as Head Referee and Crew Chief.

In addition to his football accomplishments, Scott received his Master's Degree in Criminal Justice in 1978 from Arizona State University followed by a career in public safety. Starting as a Probation Officer in Delaware, he went on to serve for ten years as a Staff Assistant to the U.S. Senate Judiciary Committee, chaired by Senator Joseph R. Biden, Jr. who later became Vice-president of the United States.

In 1994 Scott set up Lafayette Group a company in Vienna, Virginia that provides consulting, training and technical assistance to public safety agencies in the areas of communications and operational services. His company employs 60 people. Scott resides with his wife Julie in Potomac Falls Virginia with their four children Keil, Holly, Jennifer and Amanda. They are the proud grandparents of four. Scott enjoys golf and sailing but still finds time to watch a football game or two on Saturdays and Sundays.

His reaction after receiving the call that he was voted into the Central Bucks-Central Bucks West Hall of Fame, "I've been on the Big Stage and worked Super Bowls in front of 100 million viewers, but being recognized by those who I respected, admired and played with at CB West, touches me and humbles me like nothing else I have done in sports.
